Dealer agrees to exercise its best efforts to develop the largest possible market for Integrity Distribution’s product line and its accessories, and will continually offer, advertise, promote and/or demonstrate the current product line.

Distributor shall use the Ozark River Portable Sinks brand logo in all advertisements and other marketing activities conducted by the Distributor to promote the sale of the products when Integrity Distribution’s products are displayed.

Dealer will not misrepresent any of the product’s capabilities, qualities or characteristics, but shall be consistent with product information, warranty policies, literature and brochures.

Dealer Qualifications

- 1) Must have a full-time business with established catalog, printed sales material, sales representatives or active website.
- 2) Must provide a current copy of Reseller’s Certificate.
- 3) Must actively market Ozark River Portable Sinks products.
- 4) Willingness to be trained on the use, features, and benefits of our portable sinks to educate your customers accurately.
- 5) Friendly, courteous, and knowledgeable.

New Accounts

All new dealers must submit a dealer application. By completion of the application, the distributor is agreeing to the Terms and Conditions for being an authorized dealer. A copy of their current reseller’s certificate must be sent at time of application, and updated annually or as needed.

Upon approval of application and verification of Trade References, Payment Terms and Credit Limits will be established.

Payment Terms and Credit Limits

All initial orders are to be prepaid with company check or accepted and approved credit cards.

All orders for Internet-only dealers must be pre-paid in full unless arrangements are made prior to order.

All custom orders require 50% deposit at time of order, and balance due at time of custom product shipment.

Open Accounts are Net 30. Payment must be received 30 days after the invoice date.
